Sub: Scrutinizer's Report on E-voting conducted pursuant to provisions of Section 108 of the Companies Act 2013 ("the Act") read with rule 20 of the Companies (management and administration) Rules, 2014 and the physical ballot forms received from the share holders who do not have access to e-voting.

We, M/s JCA & Co, Practicing Company Secretary, Mumbai in whole time practice, had been appointed as a Scrutinizer by the Board of Directors of the Company pursuant to section 108 of the Companies Act, 2013 (the Act) read with Rule 20 of the Companies (Management and Administration) Rules 2014, for the remote e-voting process in respect of the below mentioned resolutions passed at the Annual General Meeting of the Company held on Friday, 30th September, 2022 at 02.00 p.m. We were also appointed as Scrutinizer to conduct the poll process in respect of the poll taken at the said AGM.

The voting period for remote e-voting commenced on 27th September, 2022 (09:00 A.M.) and ended on 29th September, 2022 (05:00 P.M) and the e-voting platform was blocked thereafter.
